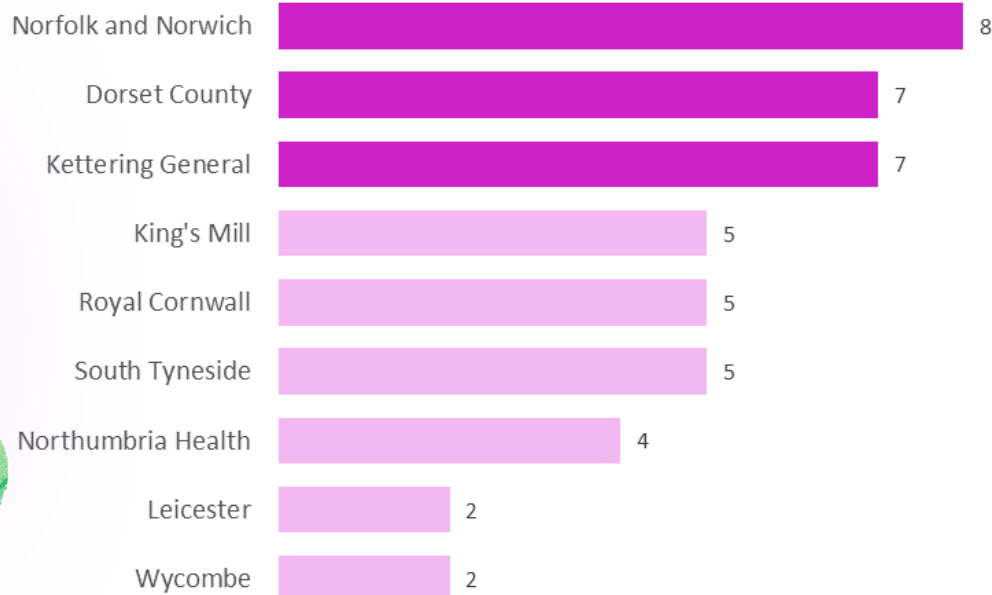
RESVERATROL SUB-TRIAL UPDATES

- The **implementation** of the Sub-Trial is expected to be in **early March**
- MHRA approval was required for a substantial amendment to the Investigational Medicinal Product Dossier (IMPD) causing a delay to the implementation of SA02. We are currently **awaiting QP release of IMP** from our partnered drug company
- We will be in touch with those who were unable to attend the **Sub-trial training sessions** soon, **thank you to all who attended** and we hope you found them helpful
- The implementation of the Sub-trial SA02 also includes **key changes to the Main Trial** discussed in further detail in the Sub-trial training presentation

REMINDERS

- Can all sites that have recruited participants ensure **data entry is up to date** on MACRO **by Friday 23rd February**. This is in preparation for our **upcoming DMC meeting** in April
- The **Resveratrol Sub-trial** and its associated documents, as part of SA02, **must not be implemented until green light** for the amendment is received by our Sponsor
- **Screening visit 1** does not have to be booked within 2 weeks after colonoscopy. We are allowing **up to 3 months to book visit 1** however, please **aim to book within 4-6 weeks**
